26 **INTRODUCTION**

27 The introduction is a beginning section of a manuscript which states the purpose of the study, overviews  
28 or summarizes previous findings and progress related to this study, and indicates its significance in this  
29 research field. It is generally followed by the body and discussion.

32 In this section, authors should describe the main text of the review in detail. It may contain a summary of  
33 representative studies in a specific field, the methods, results in previous studies, their advantages and

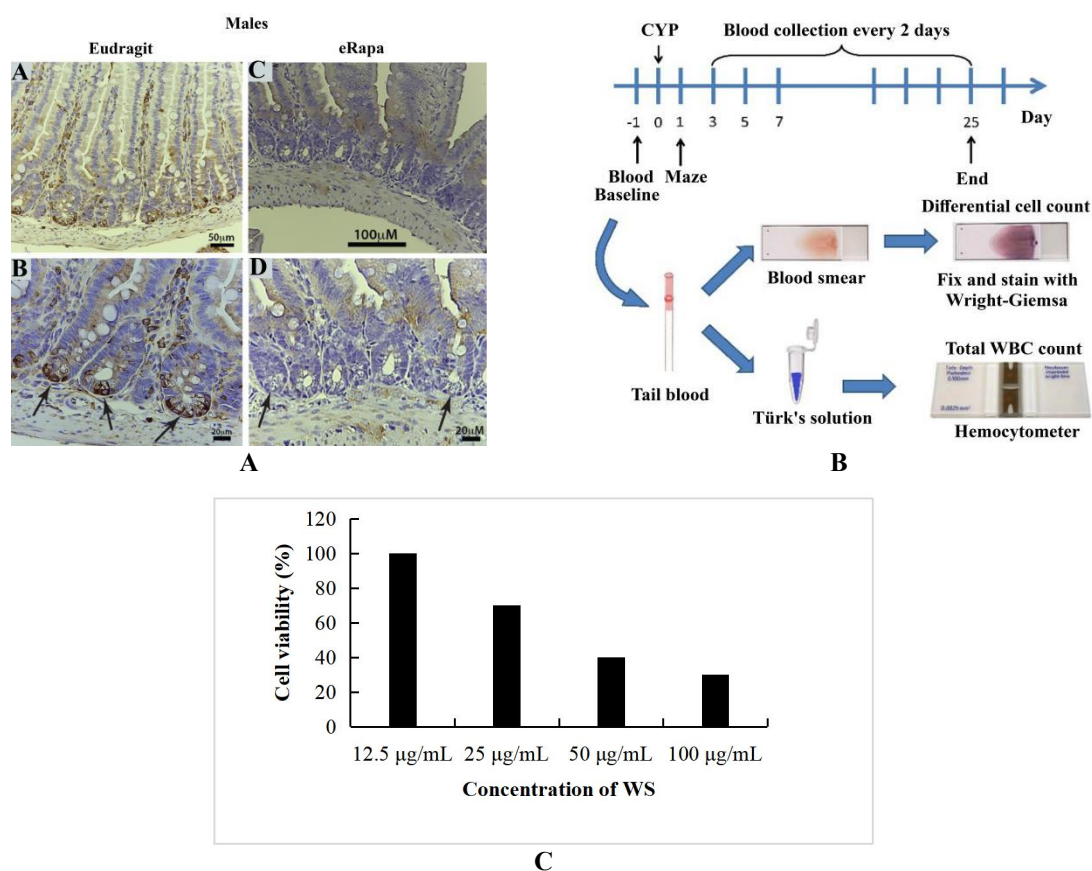

- 79 ● *Figures can be submitted in format of tiff, psd, AI or jpeg, with resolution of 300-600 dpi;*
- 80 ● *Diagrams with describing words (including, flow chart, coordinate diagram, bar chart, line chart, and*  
 81 *scatter diagram, etc.) should be editable in word, excel or powerpoint format. Non-English information*  
 82 *should be avoided;*
- 83 ● *Please use the font in “Times New Roman” format for the text in the chart*
- 84 ● *Labels, numbers, letters, arrows, and symbols in figure should be clear, of uniform size, and contrast with*  
 85 *the background;*
- 86 ● *Symbols, arrows, numbers, or letters used to identify parts of the illustrations must be identified and*  
 87 *explained in the legend;*
- 88 ● *Internal scale (magnification) should be explained and the staining method in photomicrographs should be*  
 89 *identified;*
- 90 ● *All non-standard abbreviations should be explained in the legend;*
- 91 ● *Authors should pay attention to the protection of patients’ rights, such as privacy and portrait, and obtain*  
 92 *signed patient consent from authors before using any personal information of patients. The patient’s*  
 93 *portrait with full characters and his/her real name is not allowed for use;*
- 94 ● *Permission for use of copyrighted materials from other sources, including re-published, adapted, modified,*  
 95 *or partial figures and images from the internet, must be obtained. It is authors’ responsibility to acquire the*
